Invitation to Apply for Eligibility and to Bid for the “Procurement of Security and Protective Services for the Fiscal Year 2020 to 2021”

1. The **Occidental Mindoro Electric Cooperative, Inc. (OMECO)** through its Bids and Awards Committee intends to apply the sum of **Eight Million Five Hundred Forty Six Thousand Five Hundred Fifty Three Pesos & 60/100 (PhP 8,546,553.60)** for the Fiscal Year 2020 to 2021 being the Approved Budget for the Contract (ABC) to payments under the contract for **Procurement of Security and Protective Services for the Fiscal Year 2020 to 2021**. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. **OMECO** now invites bidders to apply for eligibility and to bid for the **Procurement of Security and Protective Services for the Fiscal Year 2020 to 2021**. Delivery of the Services is required **within the Fiscal Year 2020 to 2021**. Bidders should have completed at least two (2) years in Security Services from the date of submission and receipt of bids.
3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary “pass/fail” criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the “Government Procurement Reform Act”
4. Interested bidders may obtain further information from OMECO – Bids and Awards Committee (OMECA-BAC) and inspect the Bidding Documents at the address given below during **Monday to Friday from 8:00 AM to 5:00 PM (except Holidays)**.
5. A complete set of Bidding Documents may be acquired by interested bidders from **October 27, 2019 (office hours 8:00 AM to 5:00 PM) until November 18, 2019 at 9:00 AM** from the address below and upon payment of the applicable fee for the Bidding Documents in the amount of **Ten Thousand Pesos (PhP 10,000.00)**.

It may also be downloaded free of charge from the website of the OMECO site.omeco.com.ph/Pbac, provided that Bidders shall pay the applicable fee for the Bidding Documents not later than the submission of bids.

6. The OMECO will hold a Pre-Bid Conference on **November 04, 2019, Monday at 10:00 AM** at the OMECO Multi-Purpose Hall, OMECO Main Office, Barangay Poblacion VI, San Jose, Occidental Mindoro, which shall be open to prospective bidders.

Bidders are encouraged to attend the pre-bid conference to ensure that they fully understand the Procuring Entity’s requirements. Non-attendance of the Bidder will in no way prejudice its bid; however, the Bidder is expected to know the changes and/or amendments to the Bidding Documents as recorded in the minutes of the pre-bid conference and the Supplemental/Bid Bulletin.

7. Bids must be duly received by the BAC Secretariat at the address below on or before **November 18, 2019, Monday at 9:00 AM**. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 18.

Bid opening shall be on **November 18, 2019, Monday at 10:00 AM** at OMECO Multi-Purpose Hall, OMECO Main Office, Barangay Poblacion VI, San Jose, Occidental Mindoro. Bids will be opened in the presence of the bidders' representatives who choose to attend at the address stated. Late bids shall not be accepted.

8. The OMECO reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award without thereby incurring any liability to the affected bidder or bidders.
