- 3. The Bidding Proper and opening of bids shall be on September 16-17, 2019 at 10 o'clock in the morning, Philippine Standard Time (PST); venue shall be announced during the PRE-BID CONFERENCE.
- 4. Bid documents can be purchased at the BUSECO Main Office, Tankulan, Manolo Fortich, Bukidnon from August 28 to September 4, 2019 prior to the start of the prebid conference. Only interested bidders (and/or authorized representative/s) who paid the non-refundable fee of Ten Thousand Pesos (Php 10,000.00) are allowed to participate in the pre-bid conference.
- 5. The PRE-BID CONFERENCE shall be held in BUSECO Main Office RQIM Hall, Barangay Tankulan, Manolo Fortich Bukidnon on September 4, 2019 at 10:00 o'clock in the morning (PST). Bidder who failed to attend the Pre-Bid Conference, as scheduled, can still participate during the Bidding proper. However, it will mean a waiver of their right to question any provision of the Bidding Package.
- 6. Project delivery or completion shall depend on the items to be bided.
