#### **III. TERMS AND CONDITION**

- 1. Delivery period shall be within Thirty (30) days from receipt of notice of award;
- 2. All steel poles shall be subjected to random testing on its guaranteed strength prior to delivery at the supplier's stockyard;
- 3. All meter shall be subjected to random testing on its guaranteed accuracy prior to acceptance and final payment;
- 4. ANECO, Inc. shall verify the guaranteed efficiency of the distribution transformer as submitted by the winning bidder prior to acceptance and final payment, failure to meet as guaranteed shall be rejected;
- 5. All cost incurred in relation to the testing and inspection of poles in the factory/stockyard of the winning bidder shall be for the sole account of the supplier.
- 6. If the Supplier fails to delivers the project within the specified delivery date, ANECO, Inc. shall have the right to collect penalties equivalent to 1/10<sup>th</sup> of One Percent (1%) of the total project cost of each day of delay but should not be more than Ten Percent (10%) of the total project cost;
- 7. The supplier shall warrant that the supplied steel poles shall befreefrom rust regardless of its application for the next fifteen (15) years and Warranty of the supplied meters shall not be less than three (3) years.
