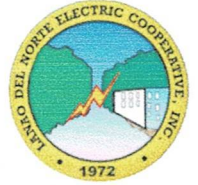

(LANECO)** through its BIDS & AWARDS COMMITTEE (BAC), invites suppliers to invitation to BID for the Supply and Delivery of 12,000 pcs brand new Electronic kilowatt-hour meters needed for Magna Carta, New Connections, and Replacement of Defective Meter and Zero Reading for the Cooperative through TERMS PAYMENT chargeable to Reinvestment Fund for Sustainable Capex (RFSC).

3. A complete set of bidding will be purchased by interested Bidder from the address below.
4. The first Delivery Schedule of the 12,000 pcs brand new electronic kilowatt-hour meter will be made within thirty (30) to forty-five (45) days after receipt of the Notice to Proceed and the remaining quantity will be delivered upon advice by LANEKO.
5. LANEKO will hold a Pre-Bid Conference (date and time stated above) which will be open to all interested parties who have purchased bidding documents. **Attendees to the pre-bid conference are only the prospective bidders or their authorized representative (through a written authorization duly notarized).**
6. Due to the threat of Covid-19, bidders have the option to come personally following the health protocols or join via ZOOM during the Pre-Bid Conference and Opening of Bids.
7. For Bidders who opt to join via ZOOM, they must confirm at least three (3) days before the Pre-Bid conference and Opening of Bids to the BAC Secretariat to facilitate the registration of participants and zoom details of the Bidding. Bidders should sign in one (1) hour before the start of meeting.
8. Bids must be submitted to the address below on or before (date and time stated above). All Bids must be accompanied by a bid security.
