The scope of work of technical specifications are contained in the Bidding Documents to be provided to all interested bidders upon application addressed to the Chairman, Bids and Awards Committee, DASURECO Main Office, Brgy. Cogon, Digos City. Non-discretionary "pass/fail" criteria will be used pursuant to Section 1 of Annex B of the IRR of RA 10531. **Bids received in excess of the ABC shall be automatically rejected at bid opening.**
3. The **Pre-Bid Conference is scheduled on July 5, 2022 (Tuesday) at 10AM** at the DASURECO Hilltop Gym, Main Office, Brgy. Cogon, Digos City which shall be open to prospective bidders via conferencing only.
4. Pursuant to the Proclamation No. 1021 and STRICT implementation of social distancing due to COVID -19 pandemic, the Procurement Service is equipped with a facility that uses video conferencing facilities to continuously communicate and collaborate with stakeholders, hence, there shall be **NO PHYSICAL MEETING** between the prospective bidders and members of the BAC.

Once the payment has been made, all interested parties may access the Pre-Bid Video Conference call through a link or meeting ID which shall be provided directly to your email before the start of the meeting. Potential bidders who access the link shall be required to input their attendance in the format, name, company and contact details as normally required in physical meeting.

5. **Bidding proper and Opening of Bids shall be on July 19, 2022 (Tuesday) at 10:00AM** venue at DASURECO Hilltop Gym, Main Office, Brgy. Cogon, Digos City. However, all bidders can only participate in the opening of bids via video conference call in the same manner as the virtual Pre-Bid Meeting.
6. Bidding Documents can be purchased at BAC Secretariat, BAC Office, New Building 3<sup>rd</sup> Floor, DASURECO, Main Office, Brgy. Cogon, Digos City from **June 24, 2022 to July 18, 2022**. Only those who have purchased the Bidding documents shall be allowed to participate in the virtual pre-bid conference and raise or submit written queries or clarification. Bidding documents for LOTS 1-4 are at **Five Thousand Pesos only (P5, 000) and is non-refundable**. Likewise, bidding forms and bid proposals can only be submitted to the same BAC Secretariat before the schedule of opening of bids.
7. **DASURECO reserved the right to accept and/or reject any Bid, to annul bidding process, and to reject all Bids at any time prior to the contract award, without thereby incurring any liability to the affected Bidder/s.**
