TO ALL PARTICIPATING BIDDERS:

This Supplemental Bid Bulletin/ Addendum No. 2023-006 is being issued to clarify, as well as modify certain items of the Bidding Documents and shall form as an integral part of the Bidding Documents. This is also in response to the queries raised during the pre-bid conference held last December 14, 2023. The following clarifications in the bid documents are as follows:

1. General Amendments/Clarifications:

A. The submission and opening of bids shall strictly proceed according to the modified schedule, as follows:

B. On Lot 3 - Supply and Delivery of Reclosers

The BAC has clarified and corrected that the number of reclosers to be acquired is actually eight (8) units. Additionally, it emphasized a preference for bid proposals that include a complimentary/freebie of one (1) laptop of any specification deemed the best offer.

Regarding the delivery schedule, the BAC has reached an agreement to extend the duration from thirty (30) to forty-five (45) calendar days.

C. On Lot 4 - Supply and Delivery of KWH Meters

After the BAC, TWG and End-User thorough deliberation and consideration, the BAC unanimously agreed that the awarding of the items under Lot 4 shall be per item.

D. On Lot 5 - Supply and Delivery of Linemen Tools and Equipment

The BAC has collectively reached a unanimous decision to extend consideration to the winning bidder for items that necessitate overseas ordering. In such cases, the delivery timeframe may be extended for up to sixty (60) days. However, items from overseas shall be specified and included in the will be submitted bids that shall be used for the evaluation of bids; hence, designate the delivery lead time for each item on the bid proposal.
