TO : ALL ELECTRIC COOPERATIVES (ECs)
SUBJECT : SITIO CONNECTIONS REPORTORIAL REQUIREMENT

As we approach the final phase of the Sitio Electrification Program (SEP) implementation, the next step is to intensify consumer connections and closely monitor the actual number of households that benefitted from the program in order to measure the impact of total electrification. Current strategies should be made sufficient to attain 90 % consumer connections by 2017.

Thus, to fulfill our mandate of pursuing total electrification of all sitios and attain an increased level of consumer connections by 2016, accounting of beneficiaries is necessary to ensure that the objective of the program had been met. Accordingly, ECs are required to submit regular connection reports to NEA-Institutional Development Department (IDD) to establish our database and rationalize the implementation of the SEP.

The EC Institutional Services Department (ISD) thru the sitio connection Focal Person is advised to submit a weekly update on the status of consumer connections to the Consumer Development and Protection Division (CDPD-IDD) for close monitoring of the program. We appreciate receiving your complete report using the attached format to also serve as your base data. Further, you are encouraged to send your submittals thru e-mail at nea_cdpd@yahoo.com. for this purpose.

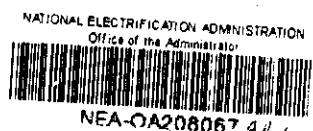
