- We are able to offer packages including turbine supply only, EPC, or Building, owning and selling power under contract



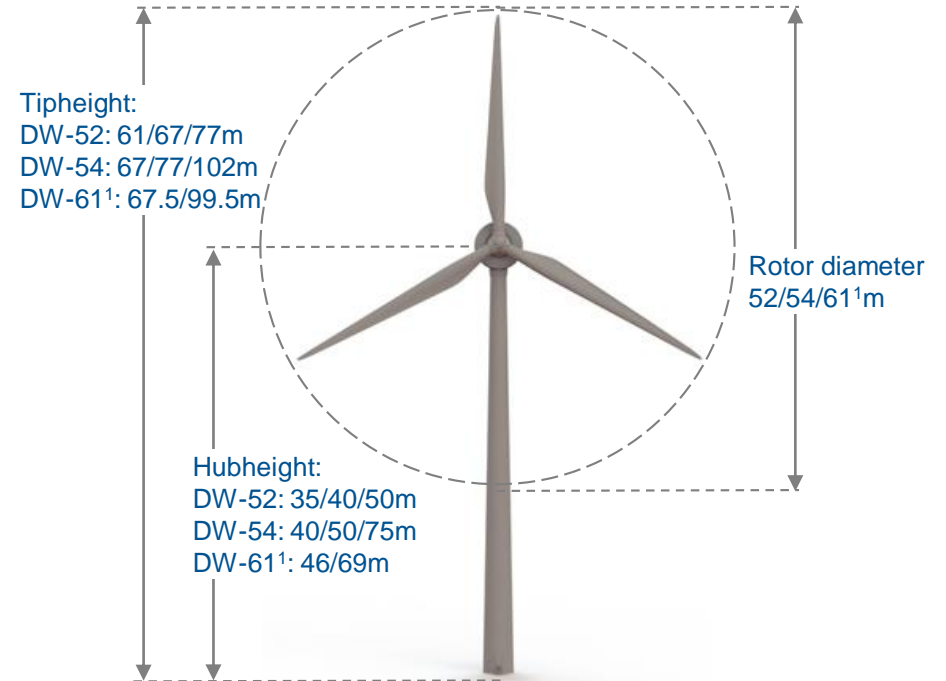

Off-grid Turbine Solutions in Alaska

- EWT installed 6 turbines at 3 locations
- EWT technical solutions:
 - Active remote power control
 - Delayed shutdown
 - No earth connection (floating earth)
 - Cold startup



Local Industrial Energy Solutions in the UK

- In 2011 EWT installed its first 500kW turbine in the UK, which was soon followed by more installations to grow to an installed base of over 200 turbines in 2016
- EWT technical solutions:
 - Power curtailment
 - Automatic Voltage Control
 - Reactive Power Compensation
 - Low voltage ride through



Mining operation in Northern Ireland

- The annual production is estimated to be over 1,000MWh of which more than half is used for self consumption at the quarry
- EWT technical solutions
 - Lightning detection system that shuts down and restarts the turbine 1 by 1
 - Fiber-optic park network
