Bidders are required to bid for the whole lot.

A. Current Transformer Outdoor 15KV

B. Potential Transformers Outdoor 15KVA – 106 units

Approved budget for the contract is Six Million Six Hundred Thousand Pesos (P 6, 600, 000.00)

Quoted price should be inclusive of VAT.

Delivery of required materials should be made within thirty (30) calendar days commencing upon receipt of the Purchase Order and Notice to Proceed.

Potential bidders must submit their company profile, latest audited financial statement and pay an accreditation fee of Two Thousand Pesos (P2, 000.00) before they are allowed to participate in the bidding process.

A complete set of Bidding Documents may be purchased starting **February 19, 2018 until 4:00 P.M. of February 27, 2018** by eligible bidders upon submission of a written application to the BAC Secretariat at the above address and upon payment of the abovementioned non-refundable fee of Ten Thousand Pesos (P 10, 000.00) for the cost of bidding documents: Questions and clarifications regarding the bid documents must be submitted on or before **February 27, 2018**.

Interested eligible bidders may inspect the bidding documents and/or obtain a copy at the office of the BAC. Pre-bid Conference will be held on **February 28, 2018, 2018 9:00 A.M.** at the TARELCO I Board Room also of the same address.

Sealed proposals must be received by the BAC at the TARELCO I office on **March 16, 2018 not later than 9:00A.M.** at which time and place the said proposal will be opened and read in the presence of Bidders or Bidders' representative who choose to attend. Late submission of sealed bid will not be considered or accepted.
