2. BISELCO now invites bids for **Purchase of Add-ons Consumers Requirements for CY-2018**. Delivery of the Add-ons materials (3 lots) is required within a period of fifteen (15) calendar days for Lot 1, twenty (20) calendar days for Lot 2, Thirty (30) calendar days for Lot 3. Bidders should have completed within three (3) years of before the date of submission and receipt of bids, a contract similar to the project. The description of an eligible bidder is contained in the bidding documents.
3. Bidding will be conducted through Public Bidding procedures using non-discretionary pass/fail criteria as specified in the National Electrification Administration's (NEA) Revised Procurement Guidelines for Electric Cooperatives.
4. Interested Bidders may obtain further information from BISELCO Bids and Awards Committee Secretariat at address given below. A complete set of documents may be acquired by interested bidders starting on April 13, 2018 from the address below upon payment of a non-refundable fee of FIVE THOUSAND PESOS (5,000.00) **for each lot** for Bidding Documents.
5. The BISELCO BAC will hold a Pre-Bid Conference on April 20, 2018, 2:00 P.M. at the Conference Room of BISELCO main headquarters, Brgy. 6, Coron, Palawan. Attendance is **optional**, which shall be open only to interested parties who purchased the Bidding Documents.
6. Bids must be delivered at the address below before April 30, 2018, 2:00 P.M. All bids must be accompanied with Bid Security of any acceptable form in the amount stated on ITB. Bids will be opened immediately after the deadline of bid submission in the presence of Bidder's representative who choose to attend. Late Bids will not be accepted.
