All bids and other documents shall be submitted in a sealed envelope addressed to the Chairman, Bids & Awards Committee, SURSECO-I, and shall be submitted on or before the set time for the Opening of Bids. The bids, together with the required documents, shall be opened on the schedule of the Opening of Bids. The same shall be held at the SURSECO-I Main Office, San Fernando, Bislig City.

Consistent with its own Procurement Guidelines/Policies and NEA issuances, SURSECO-I reserves the right to reject any and all bids, declare a failure of bidding, or not award a contract for justifiable grounds.
