

# Batanes Electric Cooperative, Inc.

## INVITATION TO BID FOR *Supply and Delivery of 2018 Buffer Stock*

1. The Batanes Electric Cooperative, Inc, through the Internally Generated Fund intends to apply the sum of Three Million Eighty Eight Thousand Nine Hundred Fifty Pesos being the Approved Budget for the Contract (ABC) to payments under the contract for each lot/item. Bids received in excess of the ABC for each lot shall be automatically rejected at bid opening.
2. The Batanes Electric Cooperative, Inc, now invites bids for 2018 Buffer Stock. Delivery of the Goods is required within 45 calendar days upon issuance of NTP. Bidders should have completed, within two (2) years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.
3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the "Government Procurement Reform Act".  
*(i) Select this paragraph if conditions (a), (c), and (d) under Section 23.4.1.2 of the IRR of RA 9184 do not exist:* Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183.
4. Interested bidders may obtain further information from *BATANELCO BAC* and inspect the Bidding Documents at the address given below from *August 9, 2018 during office hours*.
5. A complete set of Bidding Documents may be acquired by interested Bidders on *August 9, 2018* from the address below *upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the NEA Memo 2017-19*.
6. The *BATANELCO BAC* will hold a Pre-Bid Conference on *August 16, 2018, 2:00P.M.* at *BDFI Building, Brgy., Kaychanarianan, Basco, Batanes*, which shall be open to prospective bidders.
7. Bids must be duly received by the BAC Secretariat at the address below on or before *August 28, 2018, 2:00 P.M.* All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB** Clause 18.  
  
Bid opening shall be on *August 28, 2018, 2:00 P.M.* at *BDFI Building, Brgy., Kaychanarianan, Basco, Batanes*. Bids will be opened in the presence of the bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.
8. *The winning bidder shall be responsible for the transit of the goods to BATANELCO Warehouse.*
9. The *Batanes Electric Cooperative, Inc.* reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 41 of RA 9184 and its IRR, without thereby incurring any liability to the affected bidder or bidders.
