

## ILOILO II ELECTRIC COOPERATIVE, INC. Pototan, Iloilo

INVITATION TO BID FOR SUPPLY, DELIVERY, INSTALLATION, TESTING AND COMMISSIONING OF 706 UNITS OF 50WP PHOTOVOLTAIC SOAR HOME SYSTEMS INCLUDING SPARES AND WARRANTIES UNDER PV MAINSTREAMING PROJECT

- 1. The Iloilo II Electric Cooperative, Inc. (ILECO II), through the Locally Funded Project - Government of the Philippines Counterpart to Access to Sustainable Energy Program for FY 2017 (LFP - GOP to EU-ASEP FY 2018) intends to apply the sum of Sixteen Million, Five Hundred Ninety One Thousand Pesos only (Php 16,591,000.00) being the Approved Budget for the Contract (ABC) to payments under the contract for ILECO II PVM - GOP to ASEP 2018. Bids received in excess of the ABC shall be automatically rejected at bid opening.
- 2. The Iloilo II Electric Cooperative, Inc. (ILECO II) now invites bids for 706 units of 50 Wp Solar Home Systems with Lithium-ion Battery and operated by a Vending System / Prepaid. Delivery of the Goods is required within 180 calendar days upon signing of the Contract / upon receipt Project Funds - Mobilization Fund inclusive of Supply, Delivery, Installation, Testing and Commissioning. Bidders should have completed, within calendar 180 days from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II- Instructions to Bidders.
- 3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the "Government Procurement Reform Act".

Bidding is open to all interested bidders, whether local or foreign, subject to the conditions for eligibility provided in the IRR of RA 9184.

- Interested bidders may obtain further information from ILECO II BAC Secretariat and inspect the Bidding Documents at 4. the address given below from Monday to Friday during 8:00 A.M. to 4:00 P.M.only.
- 5. A complete set of Bidding Documents may be acquired by interested Bidders starting October 4, 2018 at ILECO II Main Office, Brgy. Cauayan, Pototan, Iloilo upon payment of non refundable fee of Sixteen Thousand Five Hundred Ninety One Pesos Only (Php. 16,591.00).

It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity, provided that Bidders shall pay the applicable fee for the Bidding Documents not later than the submission of their bids.

- The ILECO II will hold a Pre-Bid Conference on October 8, 2018, 1:30 P.M. at ILECO II Board Room, Main Office, 6. Brgy. Cauayan, Pototan, Iloilo which shall be opened to prospective bidders.
- Bids must be duly received by the BAC Secretariat at the address below on or before October 26, 2018, 1:30 P.M. All 7. Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 18.

Bid opening shall be on October 26, 2018 (Friday), 1:30 P.M. at the ILECO II Board Room, Main Office, Brgy. Cauayan, Pototan, Iloilo. Bids will be opened in the presence of the bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.

- The ILECO II BAC reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract 8. at any time prior to contract award in accordance with Section 41 of RA 9184 and its IRR, without thereby incurring any liability to the affected bidder or bidders.
