## **Invitation to Bid**

**LOT I: Supply, Delivery, Installation, Construction, Testing and Commissioning of 20MVA Substation at Bahay, Libmanan, Camarines Sur and**

**LOT II: Supply and Delivery of Materials and Labor for the Construction of 800meters 69kV Sub-Transmission Line at Bahay, Libmanan, Camarines Sur**

1. The **CAMARINES SUR I ELECTRIC COOPERATIVE, INC. (CASURECO I)**, through the **CASURECO I EMERGENCY CAPITAL EXPENDITURE LOAN** intends to apply the Total Approved Budget for the Contract(ABC) of **Forty Six Million One Hundred Thirty Eight Thousand Two Hundred Forty Eight Pesos and Thirty Six Centavos (Php 46,138,248.36)** being the Approved Budget for the Contract (ABC) to payments under the contract for:

**A. LOT I: Approved Budget for The Contract (ABC) Php 41,013,800.00**

To payments under the contract for the Supply, Delivery, Installation, Construction, Testing and Commissioning of 20MVA Substation at Bahay, Libmanan, Camarines Sur.

**B. LOT II: Approved Budget for The Contract (ABC) Php 5,124,448.36**

To payments under the contract for the Supply and Delivery of Materials and Labor for the Construction of 800meters 69kV Sub-Transmission Line at Bahay, Libmanan, Camarines Sur.

2. Bids received in excess of the ABC shall be automatically rejected at bid opening.
3. The **CASURECO I** now invites bids and submit letter of interest for the following:

**A. LOT I:** Supply, delivery, installation, construction, testing & commissioning of 20MVA Substation at Bahay, Libmanan, Camarines Sur.

**B. LOT II:** Supply and delivery of materials, labor, excavation, clearing, stringing, and erection/installation of 800 meters 69kV sub-transmission line at Bahay, Libmanan, Camarines Sur.

Completion of the Works is required **One Hundred Eighty Days (180 Days)**. Bidders should have completed, within ten (10) years from the date of submission and receipt of bids, a contract similar to the Project. Bidders must have a Philippine Contractors Accreditation Board (PCAB) License Category for corresponding Lot:

- A. LOT I:** at least License Category "B" and at least a Size Range of Medium A.
- B. LOT II:** at least License Category "C & D " and at least a Size Range of Small B.

The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instruction to Bidders.

4. Bidding will be conducted through open competitive bidding procedures using non-discretionary “pass/fail” criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act 9184 (RA 9184), otherwise known as the “Government Procurement Reform Act” and National Electrification Administration Memorandum No. 2017 – 19 “Revised procurement Guidelines and Simplified Bidding Procedures for Electric Cooperatives IRR-RA10531”.


Bidding is restricted to Filipino citizens/sole proprietorships, cooperatives, and partnerships or organizations with at least seventy five percent (75%) interest or outstanding capital stock belonging to citizens of the Philippines.

4. Interested bidders may obtain further information from **CASURECO I** and inspect the Bidding Documents at the address given below from November 29, 2018 until December 18, 2018 from 8:00 A.M. to 5:00 P.M. (except Saturdays, Sundays and Holidays)
5. A complete set of Bidding Documents may be acquired by interested bidders on November 29, 2018 from the address below and upon payment of a non - refundable fee for the Bidding Documents in the amount of Twenty Five Thousand Pesos (Php 25,000.00).
6. The **CASURECO I** will hold a Pre-Bid Conference on 1:30 P.M., December 7, 2018 at CASURECO I HQ, Puro - Batia, Libmanan, Camarines Sur, which shall be open only to all interested parties who have purchased the Bidding Documents.
7. Bids must be duly received by the BAC Secretariat at the address below on or before December 19, 2018 at 10:00 A.M. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB** Clause 18.



9. The **CASURECO I** reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 41 of RA 9184 and its IRR, without thereby incurring any liability to the affected bidder or bidders.
