(SORECO I) with Principal Office at Gulang-Gulang, Irosin, Sorsogon thru its Bidding and Awards Committee will receive sealed bids for the supply and installation of 10MVA substation to be installed in Brgy. Lajong but the Power Transformer will be Temporarily installed at Brgy. Sta. Teresita, all in Bulan, Sorsogon under CAPEX with corresponding Approved Budget Cost (ABC) amounting to Thirty-Six Million Three Hundred Fifty-Six Thousand Eight Hundred Four Pesos (Php36,356,804.00) inclusive of VAT.

Interested eligible bidders may obtain further information and procure the Bid Documents at the Office of the BAC Secretariat c/o Maria Milagros G. Gaspi and Flordeliza F. Evasco and attend the Pre-Bid Conference on January 05, 2018 at 10:00 in the morning upon payment of the non-refundable fee Twenty-Five Thousand Pesos (P25,000.00) starting on said date at SORECO I Board Room, Gulang-Gulang, Irosin, Sorsogon.

Sealed envelopes containing the financial and technical proposals/offers in separate envelope duly marked as such will be received by the BAC at SORECO I Board Room on or before January 19, 2018 at 10:00 in the morning at which time and place the proposals/offers will be opened first and evaluated. The proposal of bidders found eligible will be opened and read on the same date and time in the presence of the Bidders or Bidder's representatives who choose to attend, otherwise, they will be returned unopened to ineligible bidders.

This bid security shall be valid for at least 120 days, starting from the date of the bid opening. Accreditation fee shall be collected from interested Bidders in the amount of One Thousand Five Hundred (Php1,500.00) pesos only.

Delivery of all electrical materials shall be immediately upon receipt of Notice of Award, Purchase Order and Notice to Proceed. Delivery of power transformer shall be ninety (90) calendar days upon receipt of the Notice of Award, Purchase Order and Notice to Proceed and shall be in accordance to VIII additional instructions.
