**INVITATION TO BID FOR THE SUPPLY, DELIVERY, INSTALLATION, TESTING AND COMMISSIONING OF 1333 50WP PHOTOVOLTAIC SOLAR HOME SYSTEMS UNDER PV MAINSTREAMING PROJECT**

1. The Quezon II Electric Cooperative, Inc. (QUEZELCO II) through the **Locally Funded Project – Government of the Philippines Counterpart to Access to Sustainable Energy Program for FY 2017 (LFP – GOP to ASEP FY 2017)** intends to apply the sum of **Php.31,325,500.00** being the Approved Budget for the Contract (ABC) to payments under the contract for the **Supply, Delivery, Installation, Testing and Commissioning of 1333 units 50Wp Photovoltaic Solar Home Systems under PV Mainstreaming Project**. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The Quezon II Electric Cooperative, Inc. (QUEZELCO II) now invites bids for the **Supply, Delivery, Installation, Testing and Commissioning of 1333 units 50Wp Photovoltaic Solar Home Systems under PV Mainstreaming Project located in Brgy. Pagsangahan, Lumutan, Canaway, Umiray, Gen. Nakar, Quezon, Brgy. Aluyon, Burdeos, Quezon and Brgy. Maunlad, Real, Quezon**. Delivery of the Goods is required within **One Hundred Twenty (120) calendar days** inclusive of **Supply, Delivery, Installation, Testing and Commissioning**. Bidders should have completed, within Five (5) years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II No. 5 of Instructions to Bidders.
3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary “pass/fail” criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the “Government Procurement Reform Act”.

Bidding is open to all interested bidders, whether local or foreign, subject to the conditions for eligibility provided in the IRR of RA 9184.

4. Interested bidders may obtain further information from QUEZELCO II BAC Secretariat and inspect the Bidding Documents at the address given below from Monday to Friday during 8: 00 in the morning until 4:00 in the afternoon.
5. A complete set of Bidding Documents may be acquired by interested Bidders starting **November 27, 2017 at QUEZELCO II Main Office, Brgy. Gumian, Infanta, Quezon** upon payment of a none refundable fee of **Php. 25,000.00**.

It may also be downloaded free of charge from the website of the Quezon II Electric Cooperative, Inc. (QUEZELCO II) **[www.quezelco2.com.ph](http://www.quezelco2.com.ph)** provided that Bidders shall pay the applicable fee for the Bidding Documents not later than the submission of their bids.

6. The Quezon II Electric Cooperative, Inc. (QUEZELCO II) will hold a Pre-Bid Conference on **December 1, 2017 (Friday), 1:30 in the afternoon at QUEZELCO II Main Office, Brgy. Gumian, Infanta, Quezon** which shall be opened to prospective bidders.
7. Bids must be duly received by the BAC Secretariat at the address below on or before **December 13, 2017 (Wednesday) at 1:30 in the afternoon**. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB Clause Error! Reference source not found.**

Bid opening shall be on **December 13, 2017 (Wednesday) at 1:30 in the afternoon at QUEZELCO II Main Office, Brgy. Gumian, Infanta, Quezon**. Bids will be opened in the presence of the bidders’ representatives who choose to attend at the address below. Late bids shall not be accepted.

The **Bids and Awards Committee** reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 41 of RA 9184 and its IRR, without thereby incurring any liability to the affected bidder or bidders.
