Name of the contract, 2.) Date of contract, 3.) Amount of contract and value of outstanding contracts, 4.) Date of delivery and 5.) End-user's acceptance if completed**. Accreditation is subject to a non-refundable fee amounting to One Thousand Five Hundred Pesos (Php 1,500.00). Original copies of mentioned documents must be presented for proper authentication.

Bids shall be accompanied by a bid bond either in cash, Manager's or Cashier's check equivalent to two percent (2%) of the ABC or Bank Draft / Guarantee or Irrevocable letter of credit issued by a universal or commercial bank equivalent to two percent (2%) of the ABC.




