(CEBECO II), through its Bids and Awards Committee (BAC), hereby invites all interested manufacturers, suppliers, dealers, contractors and authorized franchised dealers who are clothed with a Valid Accreditation Certificate duly issued by CEBECO III to submit bids for the procurement, supply and delivery of the following materials and equipment for the "CEBECO III's President Rodrigo Roa Duterte Sitio Electrification Program Phase 2 (SEP-P2) " duly approved by the National Electrification Administration, as described hereunder for immediate reference:

The submitted documents of each bidder shall be examined and checked for completeness against a checklist of eligibility requirements to ascertain that they are all present using a non-discretionary "pass/fail" criterion.

Bidding documents will be available after the prospective bidder has been duly accredited by CEBECO III. The list of the CEBECO III accreditation requirements may be viewed at <a href="https://www.cebeco3.com.ph">www.cebeco3.com.ph</a>.

All Bids shall be opened and read in the presence of Bidders or their duly authorized representatives. Bidders shall be required to post a Bid Security in the amount equivalent to 2% of the ABC. The Bid Security shall be in the form of cash or manager's check and submitted together with their Bids. Only those bidders who have bought the bidding documents shall be allowed to attend and participate during the **pre-bid conference** and raise or submit written queries or clarifications. The presence of bidders during the pre-bid conference is **OPTIONAL**. The prospective bidder must have completed within 3 years from the date of bid opening an SLCC that is similar to the contract to be bid, and whose value, adjusted to current prices using the Philippine Statistics Authority (PSA) consumer price indices, must be at least fifty percent (50%) of the ABC.
