INVITATION FOR NEGOTIATED PROCUREMENT

In view of two (2) failed public bidding, Capiz Electric Cooperative, Inc. (CAPELCO) through its Bids and Awards Committee (BAC) invites interested bidders to participate in the Negotiated Procurement for the following:

1. Supply and delivery of Submarine Cable #2 AWG, single core, 3x2.94587 kms, 15 KV, single phase, XLPE submarine cable (made, Manufactured & Assembled in U.S., Europe, Asia except China), IEC or ANSI standards, stranded phase & neutral (wire shielded), suitable for submersion to 600 ft depth of salty water from Brgy. Agojo to Brgy. Olotayan Island
2. Cable terminations including Cable Sealing End, Link Box, Earthing / Bonding Wire, Armour Clamp, Line Hardwares of Sending and Receiving End Structures and protection equipment for the Submarine power cable both ends of the terminal station complete with the required accessories
3. Three (3) Parallel / flat formation installation (3 meters apart), laying, excavation, testing and commissioning of submarine cable including diving sets, floaters & buoys, technical divers and accessories
4. Mobilization / Demobilization
5. Other materials & equipments needed for the completion and energization of the project including ECC / permits

The total Approved Budget of the Contract is Forty Two Million Two Hundred Twenty Four Thousand One Hundred Thirty Two Pesos and Thirty Centavos (Php 42,244,132.30/100).
