5. A complete set of Bidding Documents will be purchased by interested Bidders from the address below and upon payment of a non-refundable fee for the Bidding Documents in the corresponding amount stated above.
6. The first Delivery Schedule of the brand new electronic kilowatt-hour meter will be made within forty five (45) days after receipt of the Notice to Proceed and the remaining quantity will be delivered upon advice by LANECO.

LANECO will hold a Pre-Bid Conference (date and time stated above) at LANECO Boardroom, LANECO, Sagadan, Poblacion, Tubod, Lanao del Norte, which will be opened to all interested parties who have purchased bidding documents. Attendees to the pre-bid conference are only the prospective bidders or their authorized representative (through a written authorization duly notarized).
8. Bids must be submitted to the address below on or before (date and time stated above). All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in the **INVITATION TO APPLY FOR ELIGIBILITY AND TO BID FOR THE SUPPLY AND DELIVERY OF BRAND NEW ELECTRONIC KILOWATT-HOUR METER.**
