Potential bidders must submit their company profile, latest audited financial statement and pay an accreditation fee of Two Thousand Pesos (P2, 000.00) before they are allowed to participate in the bidding process.

A complete set of Bidding Documents may be purchased starting January 21, 2019 until 4:00 P.M. of January 29, 2019 by eligible bidders upon submission of a written application to the BAC Secretariat at the above address and upon payment of the abovementioned non-refundable fee for the cost of bidding documents. Interested eligible bidders may inspect the bidding documents and/or obtain a copy at the office of the BAC. Pre-bid Conference will be held on January 30, 2019 2:00 P.M. at the TARELCO I Board Room also of the same address.

Sealed proposals must be received by the BAC at the TARELCO I office on February 12, 2019 not later than 9:00A.M. at which time and place the said proposal will be opened and read in the presence of Bidders or Bidders' representative who choose to attend. Late submission of sealed bid will not be considered or accepted.
