No. 10531), and relevant National Electrification Administration (NEA) policies, rules and regulations. Interested joint ventures and consortia shall possess the requisite special license at the time of the submission of bid documents in accordance with R.A. No. 4566 and its IRR.


Pre-bid conference and deadline for the submission/opening of bids shall be in PALECO BAC Room, at 10:00 in the morning, on January 30, 2019, and February 13, 2019, respectively. Bid documents will be available to prospective bidders starting January 21 until 3:00 in the afternoon of February 12, 2019, upon payment of a non-refundable registration fee indicated above to the PALECO teller or through bank online payment (BDO Puerto Princesa, Account Name: Palawan Electric Cooperative and Account No: 5040012315). All bids must be accompanied by a bid security in form of cash or cashier/manager's check in the amount equivalent to two percent (2%) of the Approved Budget Cost.

The above project is funded out of the national government subsidy under the Department of Energy's locally-funded project 2017 "National Intensification of Household Electrification (NIHE)" and shall be completed within the contract duration upon receipt of the Notice to Proceed.

Bidders are hereby expected to conduct due diligence prior to the pre-bid conference on the above stated projects.

PALECO hereby reserves the right to reject any or all bids, to waive any minor defects or infirmities therein, and to accept such bids as may be deemed advantageous to PALECO.
