1. The Bukidnon Second Electric Cooperative, Inc. (BUSECO) through its Bids and Awards Committee (BAC) invites interested bidders to apply to bid for the following projects with fund source from the Capital Expenditures Projects (CAPEX):

3. The Bidding Proper and opening of bids shall be on February 18-19, 2019 at 10 o'clock in the morning, Philippine Standard Time (PST); venue shall be announced

during the PRE-BID CONFERENCE.

4. Bid documents can be purchased at the BUSECO Main Office, Tankulan, Manolo Fortich, Bukidnon from February 1-6, 2019 prior to the start of the pre-bid conference. Only interested bidders (and/or authorized representative/s) who paid the nonrefundable fee of Twenty-Five Thousand Pesos (Php 25,000.00) are allowed to participate in the pre-bid conference.

5. The PRE-BID CONFERENCE shall be held in BUSECO Main Office, Tankulan, Manolo Fortich, Bukidnon on February 6, 2019 at 10:00 o'clock in the morning (PST). Bidder who failed to attend the Pre-Bid Conference, as scheduled, can still participate during the Bidding proper. However, it will mean a waiver of their right to question any

provision of the Bidding Package.

Project delivery or completion shall depend on the items to be bided.
