

## Invitation to Apply for Eligibility and to Bid for the "Supply and Delivery of Hardware & Materials, and Equipment for Add-Ons/New Connection, Distribution Line Maintenance and Rehab/Upgrading"

1. The **Occidental Mindoro Electric Cooperative, Inc.**, **(OMECO)** through the Reinvestment Fund for Sustainable CAPEX 2019 intends to apply the sum of;

being the Approved Budget for the Contract (ABC) to payments under the contract for each lot. Bids received in excess of the ABC for each lot shall be automatically rejected at the bid opening.

- 2. The OMECO now invites bids for the Supply and Delivery of Hardware & Materials, and Equipment for Add-Ons/New Connection, Distribution Line Maintenance and Rehab/Upgrading: Lot I Hardware and Materials, Lot II kWh Meters, Lot III Poles and Cross arms and Lot IV Distribution Transformer and Protection. Delivery of the Goods is required within thirty (30) calendar days from receipt of Notice to Proceed (NTP) and Purchase Order and shall be delivered in OMECO Main Office, M.H. Del Pilar St., Barangay Poblacion VI, San Jose, Occidental Mindoro.
- 3. Bidding will be conducted through open competitive bidding procedures using a nondiscretionary "pass/fail" criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the "Government Procurement Reform Act" and 2017 Revised Procurement Guidelines and Simplified Bidding Procedures for Electric Cooperatives Implementing Rules and Regulations (IRR) of Republic Act (RA) 10531.

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183.

- 4. Interested bidders may obtain further information from OMECO Bids and Awards Committee (OMECO-BAC) and inspect the Bidding Documents at the address given below during *Monday to Friday from 8:00 AM to 5:00 PM (except Holiday)*.
- 5. A complete set of Bidding Documents may be acquired by interested Bidders from *May 26, 2019 until June 17, 2019 at 9:00 AM* from the address below and upon payment of the applicable fee for the Bidding Documents in the amount of *Twenty Five Thousand Pesos (PhP 25,000.00)*.

It may also be downloaded free of charge from the website of the OMECO *site.omeco.com.ph/Pbac*, provided that Bidders shall pay the applicable fee for the Bidding Documents not later than the submission of their bids.

6. The OMECO will hold a Pre-Bid Conference on *June 3, 2019, Monday at 2:00 PM* at the OMECO Multi-Purpose Hall, OMECO Main Office, Barangay Poblacion VI, San Jose, Occidental Mindoro, which shall be open to prospective bidders.

Bidders are encouraged to attend the pre-bid conference to ensure that they fully understand the Procuring Entity's requirements. Non-attendance of the Bidder will in no way prejudice its bid; however, the Bidder is expected to know the changes and/or amendments to the Bidding Documents as recorded in the minutes of the pre-bid conference and the Supplemental/Bid Bulletin.

7. Bids must be duly received by the BAC Secretariat at the address below on or before *June 17, 2019, Monday at 9:00 AM*. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 15.

Bid opening shall be on *June 17, 2019, Monday at 10:00 AM* at OMECO Multi-Purpose Hall, OMECO Main Office, Barangay Poblacion VI, San Jose, Occidental Mindoro. Bids will be opened in the presence of the bidders' representatives who choose to attend at the address stated. Late bids shall not be accepted.

- 8. Interested bidders must express their intention to participate in the bidding through letter and submit at the address below or email at <u>omeco2018bac@gmail.com</u> not later than the scheduled Opening of Bid.
- 9. The OMECO reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 41 of RA 9184 and its IRR and 2017 Revised Procurement Guidelines and Simplified Bidding Procedures for Electric Cooperatives Implementing Rules and Regulations (IRR) of Republic Act (RA) 10531, without thereby incurring any liability to the affected bidder or bidders.
