INVITATION TO BID

The Romblon Electric Cooperative, Inc. (ROMELCO) thru its Pre-qualification Bids and Awards Committee (PBAC) invites accredited/eligible electrical contractors to submit bid for the Supply of Labor and Materials for the Construction of Distribution Lines and Household Connections for Twenty (20) sitios in ROMELCO's coverage area, particularly in the Island Municipality of Corcuera. The said project will be funded from the proceeds of Subsidy Releases from the National Electrification Administration (NEA) for Sitio Electrification Program (SEP) in the amount of Seventeen Million Two Hundred Seventy Eight Thousand Nine Hundred Thirty Nine Pesos and 98/100 (PhP17,278,939.98) and Three Million Three Hundred Forty Eight Thousand Seventy Two Pesos and 69/100 (PhP3,348,072.69) for the construction of 13.2 KV electric distribution lines, Schedule I and household connections, Schedule II, respectively.

The bidders should possess an extensive and successful experience of at least five (5) years in the construction of distribution lines in remote and isolated grids in the coverage area of the electric cooperatives.

The winning bidders shall complete the said projects within 90 days upon awarding of the contract.

All bid documents must be submitted addressed to the CHAIRMAN, ROMELCO PBAC, Capaclan, Romblon, Romblon.
