**INVITATION TO APPLY FOR ELIGIBILITY AND TO BID  
FOR THE CONSTRUCTION OF EXTENSION BUILDING FOR ZAMSURECO-I'S CENTRAL OFFICE  
ALONG GOV. VICENTE M. CERILLES STREET, PAGADIAN CITY (Turnkey Project)**


1. The Zamboanga del Sur I Electric Cooperative, Inc. (ZAMSURECO-I) now invites bidders/Contractors preferably with License Classification and Category C and above to apply for eligibility and to bid for the Project, "**Construction of New Extension Building for ZAMSURECO-I Central Office along Gov. Vicente M. Cerilles Street, Pagadian City**", with its Approved Budget for the Contract (ABC) of **PhP 23,500,352.04**. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The source of fund is coming from the General fund of the Cooperative.
3. Works shall be done within ten (10) to Twelve (12) months from the starting date of construction.
4. Bidding will be conducted through open competitive bidding procedures using a nondiscretionary "pass/fail" criterion as specified in the NEA's Procurement Guidelines and Simplified Bidding Procedures for Electric Cooperatives. All proposals shall be evaluated based on the responsiveness of the Bidder's offer to the Contract put out to bid and shall be subject to Post-qualification.
5. The project and scope of technical requirements, details, guidelines, terms and conditions are outlined in the Bid Documents which shall be provided to all applicants/Bidders upon payment of Non-Refundable fee of Twenty Five Thousand Pesos (PhP 25,000.00).
