

2. The source of fund is coming from the General fund of the Cooperative. Bids received in excess of the ABC shall be automatically rejected at bid opening.
3. The delivery period shall be within a period of 30 to 60 days, starting from the receipt of Purchase Order and Notice to Proceed. The terms of payments shall be within thirty (30) days from complete delivery and acceptance of the items put to bid.
4. Bidding will be conducted through open competitive bidding procedures using a nondiscretionary "pass/fail" criterion as specified in the NEA's Procurement Guidelines and Simplified Bidding Procedures for Electric Cooperatives. All proposals shall be evaluated based on the responsiveness of the Bidder's offer to the Contract put out to bid and shall be subject to Post-qualification.
5. The items/materials/project's scope and technical requirements details, guidelines, terms and conditions are outlined in the Bid Documents which shall be provided to all applicants/bidders upon payment of Non-Refundable fee of Ten Thousand Pesos (PhP 10,000.00).
