Invitation to Apply for Eligibility and to Bid for the "Disposal by Sale of OMECO's Non-Performing Assets on an "AS-IS WHERE IS, CLEAN-UP and ALL MUST GO" basis"

1. The **Occidental Mindoro Electric Cooperative, Inc. (OMECO)** through its Bids and Awards Committee hereby invites interested bidders to participate in the public bidding for the disposal of OMECO's non-performing assets as indicated below:

Bids received lower than the Floor Price per lot shall be automatically rejected at bid opening. The description of an eligible bidder is contained in the Bidding Documents.

- 2. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the Bidding Documents.
- 3. Interested bidders may obtain further information from OMECO Bids and Awards Committee (OMECO-BAC) and inspect the Bidding Documents at the address given below during *Monday to Friday from 8:00 AM to 5:00 PM (except Holiday)*.
- 4. A complete set of Bidding Documents may be acquired by interested Bidders from *August 25, 2019 until September 03, 2019 at 2:00 PM* from the address below and upon payment of the applicable fee for the Bidding Documents in the amount of *Five Thousand Pesos (PhP 5,000.00)*.

It may also be downloaded free of charge from the website of the OMECO <u>site.omeco.com.ph/Pbac</u>, provided that Bidders shall pay the applicable fee for the Bidding Documents not later than the submission of their bids.

- 5. Bidders are required to conduct an ocular inspection on **September 03**, **2019**, **Tuesday at 8:30 AM to 12:00 NN**.
- 6. The OMECO will hold a Pre-Bid Conference on **September 03, 2019, Tuesday** *at 2:00 PM* at the OMECO Multi-Purpose Hall, OMECO Main Office, Barangay Poblacion VI, San Jose, Occidental Mindoro. Attendees to the pre-bid conference

are only the prospective bidders who have bought bid documents, or their authorized representative (duly notarized)

Attendance of the bidders to the pre-bid conference is optional. Only those who have purchased the Bidding Documents shall be allowed to participate in the pre-bid conference and raise or submit written queries or clarifications.

- 7. Bids must be duly received by the BAC Secretariat at the address below on or before *September 17, 2019, Tuesday at 9:00 AM*. All Bids must be accompanied by a bid security in the amount stated in ITB Clause 13.
- 8. Bid opening shall be on **September 17, 2019, Tuesday at 10:00** AM at OMECO Multi-Purpose Hall, OMECO Main Office, Barangay Poblacion VI, San Jose, Occidental Mindoro. Bids will be opened in the presence of the bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.
- 9. The OMECO reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award.
