## Invitation to Bid for Supply, Delivery, Installation, Testing, and Commissioning of 878 units 50Wp Photovoltaic Solar Home Systems for PV Mainstreaming Project Under the Expanded Household Electrification Program

The CAMARINES SUR IV ELECTRIC COOPERATIVE, INC. (CASURECO IV) through the 2019 GAA Subsidy intends to apply the sum of Twenty Six Million One Hundred Thirty Thousand Thirty Six Fesos Php 26,131,036.00) being the Approved Budget for the Contract (ABC) to payments under the contract for CASURECO IV PV Mainstreaming Project 2019. Bids received in excess of the ABC shall be automatically rejected at bid opening.

The CASURECO IV now invites bids for the Supply, Delivery, Installation, Commissioning with warranty and spares for 878 units 50Wp Prepaid Solar Home Systems (SHS) with Lithium-ion Battery in the Municipalities of Ocampo, Tigaon, Lagonoy, Goa, Garchitorena and Ocampo. Delivery of the Goods inclusive of Installation and Commissioning is required within one hundred twenty days (120) calendar days. Bidders should have completed, within one hundred twenty (120) days from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II, Instructions to Bidders.

Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the "Government Procurement Reform Act".

Bidding is open to all interested bidders, whether local or foreign, subject to the conditions for eligibility provided in the IRR of RA 9184.

Interested bidders may obtain further information from CASURECO IV Bid and Awards Committee (BAC) Secretariat and inspect the Bidding Documents at the address given below, Monday to Friday at 8:00am until 5:00pm.

A complete set of Bidding Documents may be acquired by interested Bidders on October 4, 2019 from the address below upon payment of non-refundable applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of Twenty Five Thousand Pesos Only (Php. 25,000.00).

The CASURECO IV will hold a Pre-Bid Conference on October 4, 2019, 1:00 PM at CASURECO IV Boardroom, Talojongon, Tigaon, Camarines Sur, which shall be open to prospective bidders.

Bids must be duly received by the CASURECO IV BAC Secretariat at the address below on or before October 17, 2019, 1:00 PM. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause Error! Reference source not found..

Bid opening shall be on October 17, 2019, 1:00 PM at CASURECO IV Boardroom, Talojongon, Tigaon, Camarines Sur. Bids will be opened in the presence of the bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.

The CASURECO IV BAC reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 41 of RA 9184 and its IRR, without thereby incurring any liability to the affected bidder or bidders.
