Technical and Financial proposals in separate envelopes properly marked and sealed which will be opened on the date of bidding in the presence of all participating bidders.

All particulars relative to eligibility, bids evaluation and awards shall be governed by the provisions of the coop's policy on Procurement through Public Bidding.
