Deadline for the submission of the eligibility requirements will be on or before November 26, 2019 at 5:00 P.M. Bidders are also required to submit to the BAC. Technical and Financial proposals in separate envelopes properly marked and sealed which will be opened on the date of bidding in the presence of all participating bidders.

All particulars relative to eligibility, bids evaluation and awards shall be governed by the provisions of the coop's policy on Procurement through Public Bidding.
