- Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184 otherwise known as the "Government Procurement Reform Act" and the NEA Memorandum No. 2017-019 on the Revised Procurement Guidelines and Simplified Bidding Procedures for Electric Cooperatives. Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA No. 5183.
- Interested bidders may obtain further information from the ZAMCELCO BAC Secretariat Office and inspect the Bidding Documents at the address given below from 8:00AM to 5:00PM.\
- A complete set of Bidding Documents may be acquired by interested Bidders on January 31, 2025 (Friday) to February 19, 2025 (Wednesday) from the address given below or sent through electronic email upon payment of the applicable fee to be deposited at ZAMCELCO's Bank of Commerce Account No. 029-00-001214-7 and presentation of the deposit slip to the BAC Secretariat.
- The ZAMCELCO will hold a Pre-Bid Conference on February 07, 2025 (Friday) 09:00 AM via Online Video Conference or Face to Face. Attendance of bidders in the pre-bid conference is optional except when specifically stated in the Invitation to Bid. Only those who have purchased the Bidding Documents shall be allowed to participate in the pre-bid conference and raise or submit written queries or clarifications.
- Bids must be duly received by the BAC Secretariat through manual submission of two (2) hard copies of their sealed bid at the office address as indicated below on or before the deadline of receipt of bids on the bid opening date. Soft copy of their bids must also be received a day before the bid opening date but the password to be furnished on the bid opening.
