Sealed and separate envelopes containing the Eligibility Requirements (Envelope 1) and Bid Proposals (Envelope 2) duly marked as such will be received by the BAC at CASURECO IV Board Room on or before **February 6, 2019 at 1:00 P.M.** at which time and place the Envelope 1 will be opened first and evaluated. If the submitted documents (Envelope 1) found eligible, the Envelope 2 will be opened and read on the same date and time in the presence of the Bidders or Bidder's representatives who choose to attend, otherwise, they will be returned unopened to ineligible bidders.

All bids submitted must be accompanied by a bid security, in cash or manager's check, in the amount equivalent to two percent (2%) of the amount of Approved Budget Cost. The bid security shall be valid for at least 150 days, starting from the date of the bid opening.
