However, bidders who wish to bid for individual items, the prescribed rate of the bid docs in the table above shall apply.

The Pre-Bid Conference will be held at BILECO Multipurpose Building (MPB), BILECO Compound, Caraycaray, Naval, Biliran. Only those who have bought the bid documents are allowed to attend.

Sealed bids will be received by the BAC at BILECO MPB, Caraycaray, Naval, Biliran on the date and time of Bid Opening indicated above, at which time and place the eligibility requirements, technical and financial proposals will be opened and read in the presence of bidders or their authorized representatives.

Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in NEA Revised Procurement Guidelines and Simplified Bidding Procedures for Electric Cooperatives as amended and applicable rules under RA 10531.


