CEBECO III ELECTRIC COOPERATIVE, INC. (CEBECO III) through its Bids and Awards Committee (BAC), hereby invites all interested manufacturers, suppliers, dealers, authorized franchise dealers and Legitimate Labor Contractors who are clothed with a Valid Accreditation Certificate duly issued by CEBECO III and Valid Philippine Contractors Accreditation Board (PCAB) License with specialty on electrical works to submit bids for the procurement, design, supply and delivery of materials, tools, equipment and labor for the construction of a "5MVA Asturias Substation Turnkey Project" in Asturias, Cebu categorically described below for the 2018 Capital Expenditures (CAPEX) Implementation as approved by the Energy Regulatory Commission (ERC).

The submitted documents of each bidder shall be examined and checked for completeness against a checklist of eligibility requirements to ascertain that they are all present using a non-discretionary "pass/fail" criterion.

Bidding documents will be available after the prospective bidder has been duly accredited by CEBECO III. The list of the CEBECO III accreditation requirements may be viewed at www.cebeco3.com.ph.

All Bids shall be opened and read in the presence of Bidders or their duly authorized representatives. Bidders shall be required to put up a Bid Security in the amount equivalent to 2% of the ABC. The Bid Security shall be in the form of cash or manager's check and submitted together with their Bids. Only those bidders who have bought the bidding documents shall be allowed to attend or participate during the **Pre-bid Conference** and raise or submit written queries or clarifications. The presence of bidders during the pre-bid conference is **OPTIONAL**. The prospective bidder must have completed within 3 years from the date of bid opening an SLCC that is similar to the contract to be bid, and whose value, adjusted to current prices using the Philippine Statistics Authority (PSA) consumer price indices, must be at least fifty percent (50%) of the ABC.
