6. The Withdrawal Schedule of the 2 units Double Cab Dropside 4x4 will be made within one (1) month after receipt of the Notice to Proceed.

LANECO will hold a Pre-Bid Conference (date and time stated above) at LANECO Boardroom, LANECO, Sagadan, Poblacion, Tubod, Lanao del Norte, which will be opened to all interested parties who have purchased bidding documents. Attendees to the pre-bid conference are only the prospective bidders or their authorized representative (through a written authorization duly notarized).
