



4. BIR Value Added Tax registration
5. Certificate that the supplier/contractor is not black listed or banned from bidding by the government or any of its agencies and private corporations or electric cooperatives
6. Compliance with EO #398
 - a. Proof of VAT payment for the past six months
 - b. Tax clearance from BIR for the last two quarters
7. On-going, completed or awarded contract not yet started within the relevant period specifying the following:
 - a. Name of the contract
 - b. Date of the contract
 - c. Amount of contract and value of outstanding contracts
 - d. Date of Delivery
 - e. **End-user's acceptance if completed**

Please be advised, however, that there is a Non-refundable Accreditation Fee of One Thousand Five Hundred Pesos (Php1, 500.00) that is valid for one (1) year. Likewise, accredited bidders shall secure the bidding documents before the pre-bid conference.
