FY 2017 "Nationwide Intensification of Household Electrification (NIHE)" for
497 HHs in 6 Municipalities in the Province of Siquijor**

The PROVINCE OF SIQUIJOR ELECTRIC COOPERATIVE, INC. through the DOE's NIHE Locally-Funded Project FY 2017 intends to apply the sum of PHP 1,863,750.00 being the Approved Budget of the Contract (ABC) to payments under the contract for the electrification of 497 Households in the six (6) municipalities in the province of Siquijor. Bids received in excess of the ABC shall be automatically rejected at the bid opening.

Bids must be delivered to the address below on or before March 22, 2018 (until 12:00 o'clock noon)). All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB Clause 18.1**.

Bid opening shall be on March 22, 2018 at 2:00 o'clock in the afternoon at PROSIELCO Solidarity Hall, PROSIELCO Office, Nonoc, Larena, Siquijor. Bids will be opened in the presence of the Bidders or their representatives who choose to attend at the address below. Late bids shall not be accepted.
