**Invitation to Bid for Supply and Delivery of Materials and
Labor for the Construction of 69kV Sub - Transmission
Line from Tara, Sipocot to Panaytayan, Ragay,
Camarines Sur**

1. The CAMARINES SUR I ELECTRIC COOPERATIVE, INC (CASURECO I), through the NATIONAL ELECTRIFICATION ADMINISTRATION's (NEA's) 2017 CASURECO I Capital Expenditure Loan intends to apply the sum of **One Hundred Million Five Hundred Seventy Six Thousand Six Hundred Sixty Five Pesos and Seventy Three Centavos (Php 100,576,665.73)** being the Approved Budget for the Contract (ABC) to payments under the contract for **Supply and Delivery of Materials and Labor for the Construction of 69kV Sub - Transmission Line from Tara, Sipocot to Panaytayan, Ragay, Camarines Sur/CAS1 – 69STL2018**. Bids received in excess of the ABC shall be automatically rejected at bid opening.
 2. The CASURECO I now invites bids for the supply and delivery of materials, labor, excavation, clearing, stringing and erection/installation of 69kV Sub – Transmission Line from Tara, Sipocot to Panaytayan, Ragay, Camarines Sur.¹ Completion of the Works is required **One Hundred Eighty Days (180 days)** . Bidders should have completed, within ten (10) years from the date of submission and receipt of bids, a contract similar to the Project. Bidders must have a Philippine Contractors Accreditation Board (PCAB) License Category of at least “A” and at least a Size Range of Medium B. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instruction to Bidders.
 3. Bidding will be conducted through open competitive bidding procedures using non-discretionary “pass/fail” criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act 9184 (RA 9184), otherwise known as the “Government Procurement Reform Act.” and NEA Memorandum No. 2017 -019 “ Revised Procurement Guidelines and Simplified Bidding Procedures for Electric Cooperatives IRR – RA10531 (2017)”


Bidding is restricted to Filipino citizens/sole proprietorships, cooperatives, and partnerships or organizations with at least seventy five percent (75%) interest or outstanding capital stock belonging to citizens of the Philippines.
 4. Interested bidders may obtain further information from CASURECO I and inspect the Bidding Documents at the address given below starting January 31,2018 until March 4, 2018 from 8:00A.M to 5:00PM (except Saturday, Sundays and Holidays)

5. A complete set of Bidding Documents may be acquired by interested bidders on January 31, 2018 from the address below and upon payment of a non – refundable fee for the Bidding Documents in the amount of Fifty Thousand Pesos (Php 50,000.00)
6. The **CASURECO I** will hold a Pre-Bid Conference on 9:30A.M, February 20, 2018 at **CASURECO I** , Puro Batia, Libmanan, Camarines, Sur which shall be open to prospective bidders.
7. Bids must be duly received by the BAC Secretariat at the address below on or before March 5, 2018 at 9:00A.M. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB** Clause 18.


