

CAMARINES SUR I ELECTRIC COOPERATIVE, INC.

INVITATION TO BID FOR THE SUPPLY OF TIMBER MATERIALS FOR CASURECO I

1. The **CAMARINES SUR I ELECTRIC COOPERATIVE, INC. (CASURECO I)** through the **CASURECO I's Buffer Fund** intends to apply the sum of **Three Million Four Hundred Forty One Thousand Six Hundred Pesos (Php 3,441,600.00)** being the Approved Budget for the Contract (ABC) to payments under the contract for **Supply of Timber Materials for CASURECO I – CAS1-2018TM**. **Bids received in excess of the ABC shall be automatically rejected at bid opening.**
2. The CASURECO I now invites bids for the Supply of Timber Materials for CASURECO I on the following goods:

A. Timber Materials

1. **One Hundred Twenty (120) poles-** Pole, Wood, 35 feet, Class 3, Southern Yellow Pine, USA, CCA Treated, 50 years Limited Warranty.
2. **Twelve (12) poles –** Pole, Wood, 45 feet, Class 3, Southern Yellow Pine, USA, CCA Treated, 50 years Limited Warranty.

Delivery of the Goods is required in **Thirty (30) Calendar days** upon receipt of **Notice to Proceed or Purchase Order**. Bidders should have completed, within **Five (5) years** from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.

3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary “pass/fail” criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the “Government Procurement Reform Act” and National Electrification Administration Memo No. 2017-19 “Revised Procurement Guidelines and Simplified Bidding Procedures for Electric Cooperatives IIR-RA10531.

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183.


4. Interested bidders may obtain further information from CASURECO I and inspect the Bidding Documents at the address given below during office hours from **8:00 AM to 5:00 PM from Monday to Friday except Saturdays, Sundays and Holidays.**

5. A complete set of Bidding Documents may be acquired by interested Bidders from **March 19, 2018 from 8:00 AM to 5:00PM** up to up to **April 10, 2018 from 8:00 AM to 8:59 AM** from the address below and upon payment of a nonrefundable fee for the Bidding Documents, in the amount of **Five Thousand Pesos (Php 5,000.00)**
6. The CASURECO I will hold a **Pre-Bid Conference** on **March 26, 2018 – 9:30 AM** at CASURECO I, Puro Batia, Libmanan, Camarines Sur which shall be open to prospective bidders who have purchased the Bidding Documents.
7. Bids must be duly received by the BAC Secretariat at the address below **on or before April 10, 2018 at 9:00 AM**. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB** Clause 18.



9. The CASURECO I reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 41 of RA 9184 and its IRR, without thereby incurring any liability to the affected bidder or bidders.
