To qualify, interested bidders must have but not limited to the following requirements: Company profile: Notarized statement of all completed and on-going related projects (for the last 5 yrs.) with a value of at least 50% of the ABC (supported w/ contract, cert. of completion, project cost & cert. of acceptance), Copy of By-laws, Notarized statement of availability of key personnel and equipment, Notarized statement that prospective bidder is not blacklisted by any government or non-government agency; DTI Business Name registration or SEC registration certificate; Audited Financial Statements stamped received by the BIR for the immediately preceding year; Certificate of BIR Registration; Valid PCAB License with size range Small B, License Category: C&D (for Lot A only); Valid and current Mayor's Permit and Taxpayer's Identification Number.
