Bid documents can be secured from the Bids and Awards Committee (BAC) Secretariat within the dates specified above upon payment of the non-refundable fee of Five Thousand Pesos (P5,000.00) for bidders who intend to bid for all the items indicated in the Bid Schedule. However, bidders who wish to bid for individual items, the prescribed rate of the bid docs in the table above shall apply.

The Pre-Bid Conference will be held at BILECO Multipurpose Building (MPB), BILECO Compound, Caraycaray, Naval, Biliran. Only those who have bought the bid documents are allowed to attend.

Sealed bids will be received by the BAC at BILECO MPB, Caraycaray, Naval, Biliran on the date and time of Bid Opening indicated above, at which time and place the eligibility requirements, technical and financial proposals will be opened and read in the presence of bidders or their authorized representatives.

Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in NEA Revised Procurement Guidelines and Simplified Bidding Procedures for Electric Cooperatives as amended and applicable rules under RA 10531.

BILECO through the BILECO BAC reserves the right to reject any or all bids, declare failure of bidding, to waive any minor defects or informalities therein and to accept any or all offers as may be considered most responsive and advantageous to the procuring entity. It assumes no obligation whatsoever for any expenses or loss that may be incurred by the bidder in the preparation of bids, nor does it guarantee that an award will be made.


A letter expressing the intent of the Bidder to bid including its company profile and attachments must be submitted to the Bids and Awards Committee on or before May 14, 2018.
