Fifty percent (50%) of the required materials for Lot 1 Kilowatt Hour Meter for Residential should be delivered within thirty (30) calendar days and the remaining fifty percent (50%) should be delivered within sixty (60) calendar days, delivery of Lot 2 Conductor Duplex #6 should be made within thirty (30) calendar dayscommencing upon receipt of the Purchase Order and Notice to Proceed.

Potential bidders must submit their company profile, latest audited financial statement and pay an accreditation fee of Two Thousand Pesos (P2,000.00) before they are allowed to participate in the bidding process.

Sealed proposals must be received by the BAC at the TARELCO I office on May 31, 2018 not later than 9:00A.M. at which time and place the said proposal will be opened and read in the presence of Bidders' representative who choose to attend. Late submission of sealed bid will not be considered or accepted.
