**INVITATION TO BID FOR THE SUPPLY OF KILOWATT HOUR METER
FOR RESIDENTIAL AND CONDUCTOR DUPLEX #6**

TARELCO I invite eligible bidders to bid for the Supply of Kilowatt Hour Meter for Residential and Conductor Duplex #6.

Bidders are required to bid per lot.

LOT 1 10, 000 units	Kilowatt Hour Meter for Residential	----- P 21, 500, 000.00
LOT 2 200, 000 meters	Conductor Duplex #6	----- P 4, 800, 000.00

Quoted price should be inclusive of VAT.

Fifty percent (50%) of the required materials for Lot 1 Kilowatt Hour Meter for Residential should be delivered within thirty (30) calendar days and the remaining fifty percent(50%) should be delivered within sixty (60) calendar days, delivery of Lot 2 Conductor Duplex #6 should be made within thirty (30) calendar days commencing upon receipt of the Purchase Order and Notice to Proceed.

Potential bidders must submit their company profile, latest audited financial statement and pay an accreditation fee of Two Thousand Pesos (P2,000.00) before they are allowed to participate in the bidding process.

A complete set of Bidding Documents may be purchased starting **March 7, 2018 until 4:00P.M. of May 14, 2018** by eligible bidders upon submission of a written application to the BAC Secretariat at the above address and upon payment of a non-refundable fee of Twenty-Five Thousand Pesos (P 25, 000.00) for LOT 1 Kilowatt Hour Meter for Residential and Five Thousand Pesos (P 5, 000.00) for LOT 2 Conductor Duplex #6. Questions and clarifications regarding the bid documents must be submitted on or before **May 14, 2018**.

Interested eligible bidders may inspect the bidding documents and/or obtain a copy at the office of the BAC. Pre-bid Conference will be held on **May 15, 2018 9:00 A.M.** at the TARELCO I Board Room also of the same address.

Sealed proposals must be received by the BAC at the TARELCO I office on **May 31, 2018 not later than 9:00A.M.** at which time and place the said proposal will be opened and read in the presence of Bidders or Bidders' representative who choose to attend. Late submission of sealed bid will not be considered or accepted.
