

3. The Bidding Proper and opening of bids shall be on **May 29, 2018 at 10 o'clock in the morning**, Philippine Standard Time (PST); venue shall be announced during the PRE-BID CONFERENCE.
4. Bid documents can be purchased at the BUSECO Main Office, Tankulan, Manolo Fortich, Bukidnon from May 10, 2018 up to May 16, 2018 prior to the start of the pre-bid conference. Only interested bidders (and/or authorized representative/s) who paid the non-refundable fee of **Twenty-Five Thousand Pesos (Php 25,000.00)** are allowed to participate in the pre-bid conference.
5. The **PRE-BID CONFERENCE** shall be held in BUSECO Main Office, Tankulan, Manolo Fortich, Bukidnon on **May 16, 2018** at 10:00 o'clock in the morning (PST). Bidder who failed to attend the Pre-Bid Conference, as scheduled, can still participate during the Bidding proper. However, it will mean a waiver of their right to question any provision of the Bidding Package.
6. Project delivery or completion shall depend on the items to be bided.
