Interested eligible bidders may inspect the bidding documents and/or obtain a copy at the office of the BAC. Pre-bid Conference will be held on **May 29, 2018 9:00 A.M.** at the TARELCO I Board Room also of the same address.

Sealed proposals must be received by the BAC at the TARELCO I office on **June 14, 2018 not later than 9:00 A.M.** at which time and place the said proposal will be opened and read in the presence of Bidders or Bidders' representative who choose to attend. Late submission of sealed bid will not be considered or accepted.
