- Cooperative will only accept bids from those bidders/contractors that paid the non-refundable fee for the Bidding Documents.
- Bidders or authorized representatives who failed to attend the pre-bid conference will not be allowed to participate in the bidding.

Interested bidders may obtain information from the BAC Secretariat at ANECO Central Office and purchased a copy of Bidding Documents from 8:00 Am to 5:00 PM, excluding Holidays, Saturdays and Sundays upon submission of a Letter of Intent (LOI) to the ANECO BAC and subsequent payment of non-refundable Bid Fee.

The bidder shall bear all costs associated with the preparation and submission of his bid, and the cooperative will in no case be responsible or liable for those cost, regardless of the conduct or outcome of the bidding process. ANECO also reserves the right to reject any or all bids without disclosing any reason, to waive any minor defects or infirmities therein and to accept such bid as may be considered most advantageous to the cooperative.
