The National Electrification Administration (NEA) shall provide Maguindanao Electric Cooperative, Inc. (MAGELCO) a Subsidy Fund (SEP-GAA 2018) intended for line extension projects for 40 Sities in the Province of Maguindanao.

MAGELCO, through its Bids and Awards Committee (BAC), invites prospective bidders to apply for eligibility and subsequently to bid for the supply of the following

- Bidding is open to all interested bidders, subject to the conditions for eligibility provided in the IRR of RA 9184.
- Bidding shall be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified.
- Eligibility requirements to be submitted are certified true copies of the following together with the original documents to be presented during Opening of Bids for verification purposes.
  - Letter of Intent
  - Registration certificate from the Securities and Exchange Commission (SEC), Department of Trade and Industry (DTI) for sole proprietorship, or Cooperative Development Authority (CDA) for cooperatives.
  - Mayor's permit issued by the city or municipality where the principal place of business of the prospective bidder is located;
  - Valid PCAB License - Electrical Work;
  - Audited financial statements, stamped "received" by the Bureau of Internal Revenue (BIR) or its duly accredited and authorized institutions, for the preceding calendar year, which should not be earlier than two (2) years from bid submission; and
  - Statement of on-going, including contracts awarded but not yet started, and completed Government and Private projects for the last five (5) years.
- Only those who have purchased the Bidding Documents shall be allowed to participate in the Pre-Bid Conference.
- Attendance to the Pre-Bid Conference is compulsory.
- Bids shall be accompanied by a Bid Security payable to the Procuring Entity as guarantee that the successful bidder shall enter into contract upon receipt of the Notice of Award.
- Completion of work required is within ninety (90) calendar days after receipt of the Notice to Proceed.
