Approved Budget for the Contract (ABC) - P 36,088,997.31 VAT Inclusive Site Development of the Proposed Sta. Barbara Substation at Bacolor, Pampanga

Interested parties shall undergo accreditation process and are required to submit

- a.) Company Profile,
- b.) DTI Business name registration or SEC registration certificate,
- c.) Valid and current Mayors Permit/municipal license,
- d.) Tax payer's identification number,
- e.) BIR Value Added Tax registration,
- f.) Certification that the supplier/contractor is not black listed or banned from bidding by the government or any of its agencies and other private corporations or electric cooperatives.
- g.) Philippine Contractors Accreditation Board (PCAB) license (At least Category B)
- h.) Compliance with EO # 398,
 - 1. Proof of VAT payment for the past six months.
 - 2. Tax clearance from the BIR for the last two quarters,
- i.) On-going, completed or awarded contract not yet started within the relevant period specifying the following;
 - 1.) Name of the contract,
 - 2.) Date of contract,
 - 3.) Amount of contract and value of outstanding contracts,
 - 4.) Date of delivery and
 - 5.) End-user's acceptance if completed.

Accreditation is subject to a non-refundable fee amounting to One Thousand Five Hundred Pesos (**Php 1,500.00**). Original copies of mentioned documents must be presented for proper authentication.

Bids shall be accompanied by a bid bond either in cash, Manager's or Cashier's check equivalent to two percent (2%) of the ABC or Bank Draft / Guarantee or Irrevocable letter of credit issued by a universal or commercial bank equivalent to two percent (2%) of the ABC.
