2. The description of an eligible bidder is contained in the Bidding Documents, particularly in the Eligibility Requirements-Annex B.
3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion in accordance with the IRR of RA 9184 and other applicable rules and regulations.
4. Interested bidders may purchase the Bidding Documents from the BAC Secretariat Office upon payment of a non-refundable fee stated above. Pre-Bid Conference and Opening of Bids will be held at FICELCO BAPA Pavilion, Marinawa, Bato, Catanduanes which shall be opened to all bidders who have purchased the bidding documents.
5. All bids must be accompanied by a Bid Security in the form of Cash or Manager's Check made payable to FICELCO in the amount of Two Percent (2%) of the ABC.
6. FICELCO shall receive the right to accept or reject any and all bids, to annul the bidding process and to reject all bids at any time prior to contract award, without thereby incurring any liability to the affected bidders. FICELCO assumes no obligation whatsoever for expenses that may be incurred by the proponent in the preparation of their proposal or does it guarantee that an award will be made.
7. All bids must comply with the NEA approved standards and specifications.
